- The Police have apprehended a person in connection with anti-social behaviour at Vicar Water close to Rumbles and the playpark
- Clipstone Holdings have vacated the site but there have been incursions which NSDC are aware of
- There is a meeting on 10 March to discuss the Welfare and S106 monies which will extend into developing a wider strategic plan in support of Levelling Up.
- The first of the tree planting sessions at Vicar Dale took place today with the Chairman of Clipstone Parish Council also attending
- Part of Mansfield Road to the Cavendish roundabout has been re-surfaced although this appears to have temporarily knocked out some of the streetlights
- The footpath between Kings Clipstone and Clipstone needs clearance work to make it accessible
- NCC will be meeting to approve an increase to council tax of 1% and 3% for adult social care
- 10% of the social care workforce has been lost due to mandated Covid vaccinations
- Part of the Levelling Up agenda signals a combined authorities co-operative with the prospect of an elected Mayor
