- NCC Highways will also be carrying out drainage works at the 3rd Avenue and Church Road intersection.

- Working in conjunction with Clipstone Holdings to progress Levelling Up funding for new industrial units at the back of the Headstocks. This area is also anticipated to be the site of investment for sports and recreation.
- Mark Spencer MP has received a ministerial response from the MoD regarding Clipstone Cadets. The content of which is unknown at this stage. The Clipstone Cadets are looking at trial attendance at other Cadet detachments in the area but that brings logistical considerations.
- A petition has been sent to NCC lobbying for a crossing at Ruby News.
- Reports of speeding along Forest Road toward Garibaldi School have been received.
 There are already raised platforms in the road to slow traffic. It has been suggested that the raised platforms are further extend along Forest Road. Residents have said their primary concern is slowing down traffic with subsequent noise from vehicles going over the raised platforms a secondary consideration.
- Newark & Sherwood District Council (NSDC) is investigating the van/vehicle sale sites that have recently appeared in Clipstone.
- Weed spraying has taken place along the jitty of Castlefield Close to Castlefield Court
- A new nameplate will be sited at the bottom of 6th Avenue.
- Litter picking is taking place around 6th and 7th Avenues and around Clipstone centre.
- Weed spraying will take place at the end of the month.
