Cllr Scott Carlton of Notts County Council provided the following update to be read to Council:

- I attend the Remembrance Parade in Clipstone this year to lay a wreath on behalf of the County Council. This parade and service were well organised and well attended, as was the post events in the welfare.
- Over the next 18 months the council has been awarded £4.6m to advance capacity in road repairs and resurfacing programmes. This money will be on top of what the council spends in the highway's programmes.
- The theatre space at Newark hospital is now open and performing surgeries which will help reduce NHS waiting lists across the Sherwood Forest Trust footprint. i.e., Kings Mill.
- I am currently working with the Welfare Trust to rekindle the "community hub" concept as had been looked at previously. Trying to get health partners interested in the concept and will bring NCC and others into the conversation. Previously it had been looked at to relocate the library. The concept would be to put services under one roof. I continue to support and work with the Welfare and their sporting/recreational proposals.
- I recently had a catch up with the Cadets, and it is good hear that their numbers have picked up quite considerably.
- Water Leak across the B6030 near Cavendish Way roundabout (Kings Clipstone side) has been fixed by Severn Trent.
- I would like to setup a meeting with Clerk and PC councillors that are interested to talk through the bus stop improvement plan that I have raised previously. I now have a plan of what is being proposed. Hopefully this can also pick up the Forest Road proposals, as well as other county council assets in the village, i.e., as part of the previously
